

Weddings of Sarasota Member Responsibility Form 01/13

Mandatory August Bridal Show:

Fees: approx. \$350-A Type Vendors, means actively participating in show & \$175-B Type Vendors, means brochures ONLY present at show will be *by the May meeting (3rd Tuesday)*.

Payments made after the May meeting but prior to May 31st will be accepted with a \$30. late fee. The show will be closed to members, including new members after May 31st.

A mandatory bridal show Grand Prize (in the form of cash) is already included in the above approx. booth fees. This fee of \$25 included in the amount towards the Grand Prize applies to both A & B Vendors. No other prizes are required to be donated.

Dues:

Payments are due 03/01 of each year and will be accepted through mid March (specific date being the third Tuesday of March's Weddings of Sarasota breakfast meeting) with no penalty.

Payments made after mid March but no later than 3/31 will be accepted with a \$30 late fee.

Failure to pay dues by 3/31 will require a re-application and possible loss of full-membership if there is a waiting list for your category.

Dates to Note:

Please take time now to note the above critical dates on your calendars and avoid late fee penalties or termination from the membership. This new payment schedule will allow for smoother transitions through the busy holiday period and allow adequate time for corporate accounts to requisition checks in a timely manner. No exceptions will be made.

Meetings:

Meetings are consistently held the third Tuesday of every month except December. In addition, there are 4 optional evening meetings. Notice of meetings, dues etc. are sent via e-mail to all members. If communication is not received within a 30 day period - please check our website to keep up-to-date and then contact a board member to resolve the communication problem in a timely manner.
